#### The Presidents Pen

GREETINGS - Fellow compatriots. Although closing out 2008, my comments refer to the entire period our chapter has existed—May 2007 to the present. The Colonel William Grayson Chapter began with 22, but by the time the charter period closed, we had 35 members. Two of our charter members are no longer active in our chapter and regrettably, the third, Compatriot Wallace Smith, passed away early this year from cancer. With three new members registered through the chapter in 2008, we close the year with 35 members. Our chapter has experienced exceptional growth and as I'm writing we are expecting another application to be approved soon and more are in various stages of processing. Aside from growth, another indicator of chapter viability is the number of approved supplemental applications: six in 2008, and one awaiting approval by NSSAR. Two of the supplemental applications were for "Forgotten Patriot" ancestors submitted by compatriots Mike Lyman for his ancestor, John Hall, and Bill Collier for his ancestor, John Martin Beck. Compatriot David Adamy joined the SAR on a "Forgotten Ancestor," Richard Spear. Who else has a "Forgotten Patriot"? This is a program we need to support; expanding the pool of known Revolutionary War patriots is important.

We are participating in several SAR youth programs. Emily Hendrix (now a student at James Madison University) won the essay contest last year and awards were given to Prince William County and Manassas City JROTC cadets. We recognized a local businessman with the Outstanding Citizenship Award and awarded three flag display certificates. Yet, if there is room for improvement, it is our participation in the SAR community-oriented programs.

The chapter marked the graves of two Revolutionary War soldiers, Captain Bernard Hooe and Lieutenant William Flourance, both graves being in atypical locations. Hooe's grave is inside the Manassas Battlefield National Park and Flourance is buried in a local housing development.

Our chapter received very favorable coverage by a local newspaper, the Bull Run Observer, in an article written by Heidi Baumstark (newspaper staff) and published on 18 July 2008.

I'm very grateful to each of you for your participation in our chapter. Without you (and the vision and guidance of past-presidents Jim Bayne and Joe Dooley) the Colonel William Grayson Chapter, Sons of the American Revolution would not exist. I especially extend a heart-felt "thank you" to the other chapter officers for their support and good work, and the same to those who readily accepted special assignments. I also express appreciation for the VASSAR officers; being a chapter in a well organized state society is a tremendous benefit. I look forward to working with our new chapter president, Bill Broadus, and the other chapter officers in 2009. In fact, I expect our 2009 achievements to surpass our previous accomplishments.

Let us remember the mission of the SAR: Historical – Patriotic – Educational. May God bless us all, and may God continue to bless the United States of America.

    - > Essay


- Recommended additional programs and activities

### **Captain Bernard Hooe Honored with Grave Marking**

On March 9, 2008, members of the Colonel William Grayson Chapter, VASSR, assembled at the Manassas, Battlefield to dedicate a newly-installed grave marker for Captain Bernard Hooe, a second cousin once removed to General George. Washington through the General's mother, Mary Ball

Captain Hooe, was born in 1740 in Virginia and served as commander of the Prince William County Militia, commanding a company in 1777 and 1778. Following the Revolutionary War, he served as Prince William County Sheriff and was one of the original trustees for the Town of Haymarket, located in the western part of the County. He died in 1825 at Hazel Plain, Prince William County.



Captain Hooe was interred in the family plot, which is now located in the vicinity of Chinn Ridge and the remains of the Chinn House on the Manassas Battlefield. The original family headstones had been destroyed and their remnants lost many years ago. With the cooperation and assistance of Park officials and employees, Chapter members succeeded in obtaining and installing a Veterans Administration Grave Marker, as well as an SAR Revolutionary Veteran's marker.

The dedication ceremony featured remarks by Chapter President T had Hartman, a wreath laying, a gun salute by Lon Lacy, a member of the Culpeper Minute Men Color Guard, and the playing of taps by Ryan Calonder, a student at the University of Virginia.

# Revolutionary War Commemorative Knive

The Colonel William Grayson Chapter is offering a one-of-a-kind, recently manufactured, custom Buck sheath knife (with sheath) to VASSAR members. Originally a one-in-50 limited edition knife, it has been further customized by Buck's now-retired chief custom knife maker, Leroy Remer, making it even more unique.



The 5 inch blade was originally made in 1975/76 for a bi-centennial commemorative Buck knife; however, more blades were manufactured than were used at the time. The excess blades were preserved by Buck and now used for this limited edition. The blade is etched with a depiction of Paul Revere making his ride, a minuteman, the Liberty Bell, busts of George Washington, Thomas Jefferson and Benjamin Franklin, an eagle with ribbon "our rights and our liberties," and the inscription "Spirit of 76".

This one of a kind knife with 9 ¾ overall length was customized Remer and now has a handle is moose stag and an added finger guard. The sheath is leather with Liberty Bell embossed.

The knife comes in original Limited Edition box with a certificate of authenticity as a limited edition Buck knife.

# Revolutionary War History Lectures.

During the past year our chapter was fortunate to be the recipient of two Revolutionary War history lectures, presented by Glenn Willams, a retired Infantry officer who is presently on the staff of the U.S. Army Center of Military History. During our April meeting, Mr. Williams topic was "1777 -- The Year of the Hangman. He discussed British alliance with the Iroquois nation, and Iroquois raids on the Pennsylvania/New York frontier during 1777. Building on that foundation, he then addressed General Sullivan's campaign during the summer and fall of 1778 to neutralize the Irogois threat by the destruction of their villages in upper New York State. Mr. Williams is the author of a recently-published book entitled "Year of the Hangman -- George Washington's Campaign Against the Iroquois."

During the Chapter's July meeting, Mr. Williams addressed the Yorktown campaign, covering its initial planning stages, cooperation of the French Army and Navy, the march of Washington's Army from the Husdon Highlands to Yorktown, and, finally, the seige itself. The discussion was notable, not only for its comprehenvise nature but also for the discussion it also included concerning 18th century seige warfare. We are deeply indebted to Mr. Williams for his outstanding presentations which not only enriched our knowledge of the Revolution, but also enhanced our appreciation of the sacrifices made by our patriot-forbearers.

### Fallen but Not Forgotten

At its November meeting, members of the chapter were fortunate to have a presentation by COL Ward B. Nickisch (USA, ret) on the topic of "The Search and Recovery of POW/MIAs From Prior Wars". COL. Nickisch's last assignment was as the Director of Casualty and Memorial Affairs for the US Army. In that position he supervised the US Army's Central Identification Laboratory, Hawaii (CILHI), which conducted the search, recovery, identification

and repatriation of the soldiers (of all Services) whose bodies were never recovered from all prior wars. This unit became a part of the newly organized Joint POW/MIA Accounting Command (JPAC) in October 2003.

The presentation can best be described in COL Nickisch's own words from his brochures: The Presentation

provides an



update on the Nation's search and recovery operations to bring home the remains of those service members who remain "unaccounted for" from Southeast Asia, Korea and World War II.



Through the use of colored slides, the audience will be able to see actual recovery missions, and will be exposed to some of the

scientific processes (including mtDNA) used to identify the recovered remains and return them to the service member's family. Included in the presentation will be an update on recovery missions into North Korea (Democratic People's Republic of Korea) and a very significant recovery of WWII Marines from the South Pacific.

There are over 1,700 service members who remain "unaccounted for" from Southeast Asia; over 8,100

from the Korean War; and over 78,000 from WWII. The audience will gain an understanding and appreciation for our Nation's commitment and the dedication of the soldiers and civilians who conduct this arduous duty to achieve the fullest possible accounting.

#### LT William Flourance Honored with Grave Marking



On 13 September 2008, a commemoration service was held at the grave site of LT William Flourance, Jr. In attendance were members of the the Colonel William Grayson Chapter VASSAR, descendants of the patriot, interested neighbors from the surrounding housing subdivision and others.

LT William Flourence, Jr. was born 7 January 1736 and died 14 Sep 1821. LT Flourance served from Fauquier County, Virginia, and was engaged in the battles fought in North and South Carolina. Flourance ultimately moved to Prince William County and died at his son John's home and is buried in the family cemetery. This cemetery is now located in the Saranac subdivision (formerly Camp Glenkirk Boy Scout camp) off Glenkirk Road, Gainesville,

Virginia. After the Revolutionary War Flourance became a Baptist minister and was known as "Elder Flourance." Flourance family members owned several farms in the Gainesville area, including where the Virginia Oaks golf course and subdivision are located.

The commemoration ceremony was conducted by Chapter President Thad Hartman and Chaplin Rick Hendrix. Members of the family told of the life of LT Flourance and the profound effect that his story had on their own lives. This was followed with a gun salute by Compatriots Lon Lacy and Larry Alexander and by the playing of Taps by Nate Calonder, a student at Stonewall Jackson High School.

#### Where to Look for Proof of Service when the Standard Sources Fail?

This is the question posed and answered by Dr. John Sinks at the first regularly scheduled meeting of the Col. William Grayson Chapter. That meeting was held on 11 August 2007 at the City Tavern Grill in Old Town Manassas. Compatriot Sinks is past VASSAR president and immediate past VPG of the SAR mid-Atlantic Region. He has graciously granted permission to publish his talking points.

These may contain hundreds of names from a county. This is probably one of the best sources, and most overlooked sources for service from Virginia. Some of the early petitions are found under the papers of the Virginia Convention being petitioned. Most are found under the county organized chronologically. They are on microfilm, but there is no master index.

Governor's Correspondence—Virginia State Library

County Order Books—Jury service, justices, sheriffs, constables, road work, repairing court house County Will Books—appraisal of estates; laying off dower

#### DAR, SAR, and C.A.R. Papers

Some have found sources we have overlooked or are not accessible to us

Do not go in on a closed line. A line might be close because:

Error in lineage

Identity question clouds the lineage—e.g. two men named John Dorris are on the 1812 militia census and 1820 census of Robertson Co., TN. Which one was the son of the Rev. soldier Isaac Dorris and which was the son of Isaac's brother Joseph, for which there is no known service?

Error in Service--e.g. Peter Minnich closed because he was dead before the service was performed

Identity Question clouds the service—DAR has closed the line from Lt. John Gaither of Montgomery Co.

Md. Because they cannot figure out which of two men named John Gaither performed the service. DAR has closed the line of William Wood of NC. The service cited was for a public service claim processed in a county well to the east of the residence of the ancestor of the 60+ DAR applicants who had joined on the man.

Moral of the story—Resolve identity issues when you apply so the line will not be closed later.

SAR generally accepts SAR papers that are not under a cloud

SAR often does not accept DAR papers that were accepted at a time before it was not proper to ask a lady her age or sources.

Look for check marks to indicate verification.

Look for sources cited in references

Look for documentation provided with application.

In earlier eras documentation was returned to the applicant.

Generally applications from 1986 on are well verified. If the application is a short form, also get a record copy of the long form on which it is based

Our chapter has submitted two names of forgotten patriots this year. These were David Adamy's ancestor, Richard Spear, and Bill Collier's ancestor, John Martin Beck.

The chapter currently has two prospective members: **Ward Nickisch** and **Mike Taimi**.

The application process for prospective members is as follows:

- Completion of a worksheet and submission of evidence to document the bloodline to a Revolutionary ancestor and proof of his service.
- 2. Review of the worksheet and documentation by the chapter registrar
- 3. Preparation of the application form, obtaining the applicant's signature and those of a sponsor and co sponsor and submission of the completed application along with required fees.
- 4. Review and approval by the state and national registrars
- 5. Induction of the new member at a chapter meeting.

It is vital to the chapter that current members encourage friends and acquaintances to seek membership in the Sons of the American Revolution. These names should be forwarded to the chapter registrar for follow-up.


